Current Sustainability Practices & Credentials

- **FSC® Certified Manufacturer:** FSC® license FSC-C145983; responsible wood sourcing
- **SCS Indoor Advantage™ Gold:** Applicable Claridge markerboards have achieved third-party indoor air quality certification for low-emitting products. Coverage is limited to products and configurations identified in current certification documentation.
- **LCS Porcelain:** Cradle-to-Cradle Bronze certified. Claridge estimates approximately 99% of the material by weight is recyclable, subject to the availability and capabilities of appropriate recycling facilities.
- **Environmental Transparency:** Environmental Product Declarations (EPDs) and Health Product Declarations (HPDs) are available for multiple product categories as identified in current documentation.
- **Material & Waste Stewardship:** Claridge emphasizes recycling, durable material selection, and recovery of usable materials as part of its manufacturing approach.
- **Circle Action Alliance:** Claridge is a member of the Circle Action Alliance, a Producer Responsibility Organization (PRO) dedicated to the implementation of Extended Producer Responsibility (EPR) laws regarding packaging waste.

Action Framework

As additional facility and operational data become available, Claridge intends to strengthen benchmarking and establish appropriate metrics. Environmental performance claims will be supported by appropriate data or documentation.

- Consider environmental and responsible business practices in supplier evaluation and sourcing decisions.
